

**24 January, 2011**

The Dale County Commission convened in regular session Monday, January 24, 2011. The following members were present: Judge Eunice Hagler, Chairperson; District One Commissioner Douglas M. Williamson; District Two Commissioner Steve McKinnon; District Three Commissioner Charles W. Gary; and District Four Commissioner Kurt McDaniel.

Judge Hagler called the meeting to order at 6:00 p. m. Commissioner Gary opened with the Pledge to Allegiance. Commissioner McDaniel followed with prayer.

APPROVED – MINUTES – DECEMBER 13, 2010 MEETING

Mr. McKinnon made a motion to approve the minutes of the December 13, 2010 meeting. Mr. McDaniel seconded the motion. All voted aye. Motion carried.

APPROVED – INSERT FOR JANUARY 10, 2011 MEETING

Mr. Williamson made a motion to approve the insert regarding the cancellation of the January 10, 2011 Commission meeting. Mr. Gary seconded the motion. All voted aye. Motion carried.

Motion carried. Project # ER-8910(939), DCP 23-18-09 includes pile encasements and slope stabilization on County Road 9 at Mossy Camp Branch.

Mr. McKinnon made a motion to approve the Resolution for Project # DCP 23-01-11 between Dale County and the State of Alabama Department of Transportation. Mr. Williamson seconded the motion. All voted aye. Motion carried. Project #DCP 23-01-11 includes patching, spot leveling, surface treatment, and resurfacing on County Road 445 from US 84 North along CR 445 to County Road 17, approximate distance is 1.513 miles.

Mr. McDaniel made a motion to approve the Resolution for Project # DCP 23-08-10 between Dale County and the State of Alabama Department of Transportation. Mr. Gary seconded the motion. All voted aye. Motion carried.

Project # DCP 23-08-10 includes the constructing or improving of the following County Roads:

Site 1 - Spot leveling, surface treatment and striping on CR 36 east from AL Hwy 105 east along CR 36 east to AL Hwy 27, approximate distance is 9.092 miles

Site 2 – Spot leveling, surface treatment and striping on CR 47 from the Houston County line north along CR 47 to AL Hwy 134, approximate distance is 3.177 miles

Site 3 – Spot leveling, surface treatment and striping on Joe Bruer Road from US Hwy 84 east along Joe Bruer Road to the Daleville City limits, approx distance is 2.682 miles
