

**13 June, 2011**

The Dale County Commission convened in regular session Monday, June 13, 2011. The following members were present: Judge Eunice Hagler, Chairperson; District One Commissioner Douglas M. Williamson; District Two Commissioner Steve McKinnon; District Three Commissioner Charles W. Gary and District Four Commissioner Kurt McDaniel.

Judge Hagler called the meeting to order at 6:00 p. m. Commissioner McDaniel opened with the Pledge to Allegiance. Commissioner Gary followed with prayer.

RECOGNITION – MR. BILL CHESSER

Judge Hagler recognized Mr. Bill Chesser for his continuing community service in having donated 200 pints of blood.

APPROVED – MINUTES – MAY 23, 2011 MEETING

Mr. McDaniel made a motion to approve the minutes of the May 23, 2011 meeting. Mr. Williamson seconded the motion. All voted aye. Motion carried.

BIDS OPENED – CHIP SEAL RESURFACING OF VARIOUS COUNTY ROADS

Mr. McKinnon made a motion to approve the work request from the Town of Level Plains for the resurfacing of potholes in streets and driveway aprons as needed, at a rate of \$125.00 per ton – 100% reimbursement by the Town of Level Plains. Mr. McDaniel seconded the motion. All voted aye. Motion carried.

APPROVED – INSOLVENTS, ERRORS & TAXES IN LITIGATIONS – #2011-06-13-01

Revenue Commissioner Eleanor Outlaw presented a list of Insolvents, Errors, and Taxes in Litigation for FY 2010 and requested the list be approved. Mr. Gary made a motion to approve the list. Mr. McKinnon seconded the motion. All voted aye. Motion carried.

Mr. Gary made a motion to approve the employment of Kenneth P. Smith as a Sanitation Helper, Grade IV, at a salary of \$8.50 per hour, effective June 15, 2011. Mr. Williamson seconded the motion. All voted aye. Motion carried.
