Commissioner Strickland asked if the Revenue Commissioner had found ways to possibly alleviate some of the long lines in the tag department. There was also discussion about eliminating the \$2.00 mail fee on tag renewals to encourage the citizens to get their tag renewals by mail.

County Engineer Derek Brewer announced that County Road 49 and County Road 1 were closed due to flood damage from the recent rains.
