The Dale County Commission convened in regular session Monday, March 25, 2013. The following members were present: Mark Blankenship, Chairman; District One Commissioner Douglas M. Williamson; District Two Commissioner Steve McKinnon; and District Four Commissioner James W. Strickland. District Three Commissioner Charles W. Gary was absent.

Chairman Blankenship called the meeting to order at 6:00 p. m. Commissioner McKinnon opened with the Pledge to Allegiance. Commissioner Strickland followed with prayer.

MINUTES – MARCH 11, 2013 REGULAR SESSION

Commissioner McKinnon made a motion to approve the minutes of the March 11, 2013 regular session. Commissioner Strickland seconded the motion. All voted aye. Motion carried.

Commissioner McKinnon made a motion to approve the implementation of two satellite offices for vehicle registrations, one to be located in Daleville and the other to be located in either Midland City or Pinckard. Commissioner Strickland seconded the motion. All voted aye. Motion carried.

APPROVED – RENOVATIONS TO CREEL RICHARDSON BUILDING FOR SHERIFF'S OFFICE

Commissioner Strickland made a motion to approve the renovation to the Creel Richardson Building for the Sheriff's Office use. Total estimated cost is \$15,125.00 and the County will do some of the work in-house. Commissioner McKinnon seconded the motion. All voted aye. Motion carried.

APPROVED – PHONE SYSTEM – COURTHOUSE

Commissioner McKinnon made a motion to authorize the purchase of a new Century Link Business PRI Circuit System phone system for the Courthouse. Total cost of system is approximately \$77,282.98, which includes rewiring the Courthouse. Commissioner Williamson seconded the motion. All voted aye. Motion carried. Commissioner McKinnon also wanted noted that this is the same system that is going in the Government Building and that is currently being utilized by the E911/EMA Offices and that all three systems can be linked.

APPROVED – 'DON'T DROP IT ON ALABAMA' SPRING CLEAN UP

Mr. McKinnon made a motion to approve participation in the "Don't Drop It On Alabama" Spring Cleanup, April 20-27, 2013, having the Dale County Inert Landfill open on April 27, 2011 and charge no dumping fees for residents (contractors will be charged the usual fees). Mr. Williamson seconded the motion. All voted aye. Motion carried.
