The Dale County Commission convened in regular session Monday, April 8, 2013. The following members were present: Mark Blankenship, Chairman; District One Commissioner Douglas M. Williamson; District Two Commissioner Steve McKinnon; District Three Commissioner Charles W. Gary; and District Four Commissioner James W. Strickland.

Chairman Blankenship called the meeting to order at 5:30 p. m. Commissioner McKinnon opened with the Pledge to Allegiance. Commissioner Gary followed with prayer.

MINUTES – MARCH 25, 2013 REGULAR SESSION

Commissioner McKinnon made a motion to approve the minutes of the March 25, 2013 regular session. Commissioner Strickland seconded the motion. All voted aye. Motion carried.

AGREEMENT – DALE COUNTY & ADEM – COLLECTION & DISPOSAL OF DISCARDED TIRES & REGULATED SOLID WASTE - #2013-04-08-01

Commission Gary made a motion to approve entering into an agreement with ADEM for the collection, management, disposal, and/or offering for beneficial use, of discarded tires and regulated solid waste. This agreement is for three years and up to \$300,000.00 in reimbursement. Commissioner McKinnon seconded the motion. All voted aye. Motion carried.
