

## **August 26, 2013**

The Dale County Commission convened in regular session Monday, August 26, 2013. The following members were present: Mark Blankenship, Chairman; District One Commissioner Douglas M. Williamson; District Two Commissioner Steve McKinnon; District Three Commissioner Charles W. Gary; and District Four Commissioner James W. Strickland.

Chairman Blankenship called the meeting to order at 5:30 p. m. Commissioner Strickland opened with the Pledge to Allegiance. Commissioner Gary followed with prayer.
